Advanced Standing/Recognition of Prior Learning (RPL) for CCPU Units This form is to be submitted simultaneously with a completed <u>ASUM Membership Application Form</u> (if not already a member) and the

CCPU Enrolment Application Form.

Candidates may apply to have their training and practice recognised as meeting the requirements of one or more CCPU units. In assessing your application for Advanced Standing or RPL, the CCPU Board of Examiners needs to consider if you have gained the equivalent experience and knowledge that you would have achieved had you undertaken the approved activities. When awarding advanced standing the ASUM CCPU Certification Board will specify the elements of the CCPU for which credit has been awarded and those elements which the applicant is required to complete. To assist assessment of your application, we ask you to provide the following:

Supporting documentation:

Please note: It is possible that RPL may be recognised without all of the following documents. However, it is in your best interests to provide as much evidence of ultrasound experience as possible.

- 1. Evidence of ultrasound courses attended.
- 2. Evidence that reflects the logbook requirements contained in the relevant CCPU syllabus. If this has occurred over more than two years, describe how many scans you have performed in the last two years. Please advise if you have a logbook or equivalent documenting your experience and include any description of QA activities performed for ultrasound.
- 3. A letter of support from Head of Department or senior colleague confirming use of ultrasound for the period defined and detailing competence as judged by a clinical colleague.
- 4. A letter of support from other Sonologists or sonographers confirming use of ultrasound and competence in the described areas.
- 5. A list of any publications and presentations that relate to ultrasound.
- 6. Evidence of involvement in teaching of ultrasound. Please include copies of unit materials.
- 7. Evidence of any other ultrasound qualifications completed.
