Audit Results: Room for Improvement

Dr Eilidh Dempster audited the documentation and quality of US scans from the month of May and presented this at Wednesday Teaching. The findings were as follows:

- Only 59% of scans were documented at all
- **12%** of scans were documented in a separate progress note (the recommendation here at TSH ED)
- 47% of patients had the expected minimal 4 identifying data points entered into the machine for each scan
- **32%** of saved scans were adequate (were able to rule in/out pathology)

We clearly need to step up our game as a department and *everyone can play a part improving our performance* – nursing staff and other non-ultrasound users included!

If you see someone perform a scan it is ok to ask them *'have you documented?'*, even if it's a Consultant. There is a guide to setting up a precompleted PoCUS note on the website along with the ECI/EMUGs checklist for performing an US which outlines the minimum machine data set. http://www.sutherlanded.com/pocus/sutherland-ed-us-guidelines/ We will be auditing again before Christmas.

Always liaise with a FACEM if you are performing a scan that will potentially change patent management (especially those being discharged). Not all consultants are credentialed in PoCUS but most have considerable US experience. Ultimately, they will decide whether to take responsibility for the scan when there no credentialed provider on shift. The ASUM CCPU credentialed doctors who can review your scans are **Kirsty Short, Anthony Van Assche and Matthew Bode**.

One Product ONLY: Cleaning with Clinell
